

### WILLIAM DESJARLAIS MEMORIAL BURSARY FUND

#### **PURPOSE:**

The purpose of the William Desjarlais Bursary Fund is to provide a bursary to Settlement Members of children of Settlement Members to assist with funding for costs related to Post Secondary certified educational programs delivered through a provincially registered, recognized institute. Two bursaries, each valued at \$3,000.00 will be awarded to Settlement Member or children of residing Settlement Members in pursuant of an educational career of their choice.

#### **DEFINITION:**

"Bursary" educational assistance given in the form of a grant in honor of the late William Desjarlais;

"Child" means a child of a settlement member under the age of 18 years;

"Council" means the elected Council Members of the Fishing Lake Metis Settlement;

"Letter of Acceptance" means a letter elected from the Post-Secondary Institute confirming the Member or Member child has been accepted to attend.

"Post-Secondary" means a learning institution registered as a College or University by the Government in which jurisdiction the institute is licensed to operate.

"Post-Secondary Course" means a course, minimum of 3 months, offered at a registered college or university.

"Settlement" means the Fishing Lake Metis Settlement.

"Settlement Member" means a registered Member of the Fishing Lake Metis Settlement

#### **ELIGIBILITY**

To be eligible for a bursary the applicant must:

- Provide proof of application and acceptance into a Post-Secondary or certified educational program delivered by a Provincially registered, recognized Post-Secondary Institute;
- 2. Be a Settlement Member or a child of a Settlement Member;
- 3. Must have a minimum of Grade 9 secondary education;
- 4. Submit a completed, signed William Desjarlais Memorial Bursary application;
- 5. Must have not received this bursary more than twice in the past.

#### **APPROVAL PROCESS:**

- 1. Applications must be submitted to the Settlement Council by March 31;
- If no bursaries are disbursed or committed by May of the same fiscal year, a second deadline application of August 31 will be posted;
- Once the Desjarlais family has received all documentation required in an application for a Bursary, the William Desjarlais "immediate" family members and heirs will make a selection for the successful candidate and notify Council of the successful application.

#### **EFFECTIVE DATE:**

This Policy comes into effect upon adoption by the Desjarlais Family
