

FISHING LAKE METIS SETTLEMENT IN THE PROVINCE OF ALBERTA

SPEED LIMIT BYLAW

BYLAW #2006 - 0157

A BY-LAW PROVIDING FOR THE ESTABLISHMENT OF SPEED LIMITS ON THE ROADS WITHIN THE BOUNDARIES FISHING LAKE METIS SETTLEMENT.

WHEREAS Section 109 of the Metis Settlements Act, S.A. 1990, c. M-14.3 provides that a Settlement Council has the direction, control and management of all highways, roads, streets and lanes within the boundaries of the Fishing Lake Metis Settlement that are not subject to the direction, control and management of the Crown in right of Alberta.

NOW THEREFORE the Council and members of the Fishing Lake Metis Settlement enact as follows:

Purpose

1.

The purpose of this bylaw is to establish speed limits on highways, roads, street and lanes with the Settlement area.

Definition

2.

For the purpose of this policy

"Council" means the elected council of the Fishing Lake Metis Settlement.

"Highways" means any thoroughfare, street, road, trail, avenue, parkway, driveway, lane, or alley, whether publicly or privately owned, any part of which the public is ordinarily entitled or permitted to use for the passage or parking of vehicles;

Established Speed Limit

3. 1. The Speed Limit on the Paved road running from the north boundary of the Settlement to the south boundary shall be set at 80km. Per hour; (Pink road on the attached map); or as otherwise posted.
2. The Speed limit on all other main roads shall be set at 80km. Per hour; (Pink area on the attached map); or as otherwise posted.
3. The speed limit within 1km. Of the Hamlet area is set at 50km. Per hour; (Highlighted in light purple on the attached map); or as otherwise posted.
4. The Speed limit within the Hamlet is set at 30km. Per hour; (Highlighted in yellow on the attached map). or as otherwise posted.

Amends

4. 1. Council may at anytime amend the established speed limits in this bylaw by way of Council motion and the change will be in affect on the date of the Council motion.

PENALTY

5. The penalty for speeding on Settlement roads will be as determined by the Provincial Highway Traffic legislation and all of it's regulations.

Effective Date

This bylaw comes into effect the day after it is given third reading.
